

# Vehicle Use Agreement for Home Stay

## 8. Accidents and Incidents

- In the event of an accident, theft, or damage:
  - The Guest must notify the Owner and the police (if applicable) **immediately**.
  - A detailed written report including photos and a copy of any police report must be provided within 24 hours.
  - The Guest must **cooperate fully with the Owner and insurance company** in any investigation or claim process.

## 9. Termination of Use

The Owner reserves the right to terminate this agreement at any time for breach of its terms or safety concerns. The Guest must immediately return the vehicle upon request.

**10. Liability Waiver**

To the fullest extent permitted by law, the Owner shall not be liable for any indirect, incidental, or consequential damages arising from the Guest's use of the vehicle, including but not limited to loss of enjoyment, personal injury, or property damage.

---

**11. Governing Law**
